### Insurance Fee

An annual insurance fee of \$25 is required to cover all damage to the device with a \$0 deductible. If the \$25 insurance fee is not paid, the Parent/Guardian will be responsible for a \$75 fee the first time the device is damaged, regardless of the cause of the damage done, and a \$50 fee will be required for each subsequent damage repair request. All repairs must be completed by the Lee County School Technology Department.

### Acceptable Use Policy Agreement

I have read the Student Acceptable Use Guidelines located in the Student/Parent Device Agreement. I understand that the Internet is a worldwide group of multiple computer networks. I agree that Lee County Schools does not control the content of these Internet networks. I understand if my child violates the Acceptable Use Guidelines, their access privilege to the District Internet may be revoked and is subject to disciplinary action. Lee County Schools has my permission to give Internet access to my child. I understand that my child will maintain this privilege as long as the procedures described in the Lee County Schools Student/Parent Device Agreement are followed.

### Terms of Agreement

Lee County Schools grants permission to the student to have limited use of the device described in this agreement. The student is responsible for the care and appropriate use of this device at all times when the device is not in storage by Lee County Board of Education. The device remains the property of Lee County Schools and cannot be loaned, sold, bartered, traded, leased, rented or given to any other person or persons without the express, written consent of Lee County Schools. The district insurance and the permission granted to the student ceases on the last calendar day of the current school year (unless terminated earlier by Lee County Schools) and failure to return the said device on or before that date to the campus principal or their designee will result in criminal charges being sought against the student and/or the person who has the device. Lee County Schools reserves the right at any time to demand return of the device forthwith.
