THE TRUANCY PROCESS AND THE EARLY WARNING MEETING PURPOSE





EARLY WARNING SYSTEM (EWS)

The Early Warning System (EWS) is designed to assist in addressing at-risk factors such as:

- Attendance,
- Behavior, and
- Course attainment or school failure.

THESE ARE **FACTORS** IN THE TRUANCY PROCESS. HOWEVER, TODAY'S MEETING WILL ONLY FOCUS ON **ATTENDANCE**.

Parents and students often don't see the **true impact** of missing school until it has a **cumulative NEGATIVE impact**, such as failing grades due to missing class.



ATTENDANCE IS OFTEN THE BEST FACTOR
THAT LETS US KNOW THAT A STUDENT IS
AT-RISK OF FAILING!



ALABAMA SCHOOL ATTENDANCE FAQS



• ANY CHILD ENROLLED AT THE AGE OF FIVE AND ALL CHILDREN BETWEEN THE AGES OF SIX AND SEVENTEEN BY LAW MUST ATTEND SCHOOL

AUTHORITY: ALA. CODE §16-28-3 (1975)
AMENDED BY ALABAMA ACT 2019-447, §1, EFF 9/1/2019

- ATTENDANCE IS A KEY INDICATOR OF A STUDENT'S CONNECTION WITH SCHOOL AND THEIR LIKELIHOOD TO GRADUATE HIGH SCHOOL.
- THE MAJORITY OF STUDENTS WHO "DROP-OUT" FIRST STOP ATTENDING SCHOOL ON A REGULAR BASIS, IN MANY CASES THEIR ATTENDANCE DECREASES OVER SEVERAL YEARS

• A STUDENT MAY NOT "DROP-OUT" WITHOUT THE CONSENT OF HIS/HER PARENTS OR GUARDIANS

AUTHORITY: ALA. CODE §16-28-3.1(1975)

• A WRITTEN EXCUSE IS REQUIRED FOR ANY ABSENCE(S)

AUTHORITY: ALA. CODE §16-28-15(1975) ACTS 1982, NO. 82-218,P. 260, §7

• MANY TIMES CHRONIC ATTENDANCE PROBLEMS
START IN ELEMENTARY SCHOOL WHEN THE CHILD
IS NOT IN CONTROL AND A PATTERN OF NON—
COMPLIANT BEHAVIOR BEGINS THAT CANNOT BE
MANAGED WHEN THEY ARE OLDER

ROLE OF THE ATTENDANCE OFFICER





- ATTENDANCE OFFICERS MUST INVESTIGATE ALL REPORTED CASES OF NON-ENROLLMENT OR NON-ATTENDANCE. WHEN THERE IS NO VALID REASON FOR THE NON-ENROLLMENT OR NON-ATTENDANCE, THE ATTENDANCE OFFICER SHALL GIVE THE PARENT...NOTICE REQUIRING ATTENDANCE OF THE CHILD.
- THE ATTENDANCE OFFICER IS LEGALLY REQUIRED TO BRING CRIMINAL PROSECUTION AGAINST THE PARENT, GUARDIAN, OR OTHER PERSON IN THOSE CASES FOUND TO BE WITHOUT VALID EXCUSE. ALA. CODE §16–28–16(1975) ACT 2001–344, P. 446, §1.

THIS PROSECUTION WILL RESULT IN A COURT DATE IN LEE COUNTY'S JUVENILE COURT

EMAKE - UP WORK, RETENTION & COURSE CREDIT



STUDENTS MAY NOT BE ALLOWED TO MAKE-UP WORK FOR UNEXCUSED ABSENCES

PARENT NOTES MAY EXCUSE A MAXIMUM OF FIVE (5) ABSENCES PER SEMESTER AND MUST BE SUBMITTED NO LATER THAN 3 DAYS AFTER RETURNING TO SCHOOL

PROMOTION/RETENTION: ABSENCES IN ELEMENTARY AND MIDDLE SCHOOLS (GRADES K-8)

A student may be retained if unexcused absences exceed ten (10) unexcused days per year

TRUANCY & CHRONIC ABSENTEEISM



- TRUANCY... IS THE FIRST SIGN OF TROUBLE
- > POOR ATTENDANCE CAN INFLUENCE WHETHER CHILDREN READ PROFICIENTLY BY THE END OF THIRD GRADE OR BE HELD BACK
- BY 6TH GRADE, CHRONIC ABSENCE BECOMES A LEADING INDICATOR THAT A STUDENT WILL DROP OUT OF HIGH SCHOOL
- RESEARCH SHOWS THAT:

ATTENDANCE IS EIGHT TIMES MORE PREDICTIVE OF FAILURE THAN PRIOR TEST SCORES. IT HAS CLEARLY BEEN IDENTIFIED THROUGH DATA ANALYSIS THAT ATTENDANCE IS A MAJOR, IF NOT THE BIGGEST, FACTOR IMPACTING OUR STUDENTS ACADEMICALLY AND BEHAVIORALLY.

Truancy Vs. Chronic Absence

Vs.

TRUANCY

- •Counts only unexcused absences
- •Emphasizes compliance with school rules
- •Relies on legal & administrative solutions

CHRONIC ABSENCE

- Counts all absences: excused, unexcused & suspensions
- Emphasizes academic impact of missed days
- Uses community-based, positive strategies









Upon the **first** unexcused absence, the parent/guardian shall be notified that the student was truant and the date of the truancy

PARENTS RECEIVE A PHONE CALL, TEXT MESSAGE,
AND EMAIL EACH DAY THEIR CHILD HAS AN
UNEXCUSED ABSENCE.

LCS ATTENDANCE STEPS

THIRD TRUANCY/UNEXCUSED ABSENCE (WARNING)

Upon the **third** unexcused absence, the parent/guardian shall be notified in writing by the school principal or their designee on the student's truancy status.

THIS IS THE FIRST LETTER SENT HOME, MAY BE EMAILED TO THE PARENT, GIVEN TO THE STUDENT TO BRING HOME OR MAILED TO THE HOME ADDRESS

LCS ATTENDANCE STEPS

FIFTH TRUANCY/UNEXCUSED ABSENCE

THIS IS THE SECOND LETTER SENT HOME, MAY BE EMAILED TO THE PARENT, GIVEN TO THE STUDENT TO BRING HOME OR MAILED TO THE HOME ADDRESS

At the 5th unexcused absence, the parent(s)/guardian(s) will be notified via truancy letter by the school principal or his/her designee that the student was truant and the date of the absences. This will serve as an official notification of student's truancy and possible consequences to follow if unexcused absences continue to occur.



FAILURE TO APPEAR AT THE SCHOOL CONFERENCE AND/OR FAILURE TO APPEAR AT THE EARLY WARNING PROGRAM SHALL RESULT IN THE FILING OF A PETITION AGAIN THE PARENT UNDER THE CODE OF ALABAMA (1975) 516-28-3, (FAILURE TO COOPERATE), OR TRUANCY CHARGE AGAINST THE STUDENT, WHICHEVER IS APPROPRIATE

LCS ATTENDANCE STEPS

SEVENTH TRUANCY/UNEXCUSED ABSENCE

LAST EFFORT TO COMMUNICATE!

At the 7th unexcused absence, a conference will be scheduled by the school level personnel with the parent/guardian, a school administrator and various members of an attendance team to actively identify, and if needed, to resolve the student's attendance problem. School level personnel will complete referral form notifying attendance liaison of meeting details.

A WRITTEN "ATTENDANCE AGREEMENT" WILL BE COMPLETED AT THIS MEETING.



Failure to appear at the school conference and/or failure to appear at the Early Warning program shall result in the filing of a petition again the parent under the Code of Alabama (1975) 516-28-3, (failure to cooperate), or truancy charge against the student, whichever is appropriate

LCS ATTENDANCE STEPS

TENTH TRUANCY/UNEXCUSED ABSENCE

At the 10th unexcused absence, a petition/complaint is subject to be filed against the parent(s)/guardian(s) and child (when age appropriate) with the Juvenile Court of Lee County



§ Any student ordered to court with a truancy petition could be adjudicated to CHINS (Children in Need of Supervision) by a court judge. A judge can order additional supervision and services through East Alabama Mental Health, Department of Human Resources, or alternate placements outside the home setting. Additional fees and community service may also be ordered by a judge.

§ Any custodial adult who is prosecuted for failing to require a student to attend school may be jailed for up to one (1) year or fined up to \$500.00 or both.

DRIVER'S LICENSE REVOCATION



STUDENTS 15–19 YEARS OF AGE WHO DROP OUT OF SCHOOL OR MISS 10 CONSECUTIVE OR 15 CUMULATIVE UNEXCUSED ABSENCES WITHIN A SEMESTER WILL HAVE THEIR DRIVER'S LICENSE SUSPENDED.

- Students must show compliance and pay a \$200 fee to have their driver's license reinstated, AND
- Satisfactory progress in a GED program, or the obtainment of a GED certificate constitute compliance, OR
- Regular school attendance constitute compliance
 - One quarter with an 80% attendance rate and no unexcused absences constitutes regular school attendance.

AUTHORITY: ALA. CODE §16-28-40(1975)

DENIAL OF WORK PERMIT

AN ELIGIBILITY TO WORK FORM SHALL ALLOW THE EMPLOYMENT OF A PERSON 14 OR 15 YEARS OF AGE WHO IS DOING SATISFACTORY SCHOOLWORK TO WORK ONLY OUTSIDE SCHOOL HOURS OR DURING VACATION PERIODS, AND ONLY IN OCCUPATIONS NOT PROHIBITED BY THIS CHAPTER FOR PERSONS OF THESE AGES.

Authority: Ala. Code §25-8-46(1975)

Any 14 or 15 year old student that does not attend school regularly or performing satisfactory shall have the worker's permit revoked or suspended



SUBMITTING EXCUSES

- THE MOST COMMON REASON FOR AN EARLY WARNING INVITATION OR PETITION IS BECAUSE A
 STUDENT'S EXCUSES WERE NOT SUBMITTED ON TIME AFTER COMING BACK TO SCHOOL.
- EXCUSES MUST BE SUBMITTED WITHIN 3 DAYS OF RETURNING (STATE POLICY).
- EXCUSES CAN BE SUBMITTED ELECTRONICALLY OR ON PAPER.
- ONLINE SUBMISSIONS ARE HIGHLY ENCOURAGED!





RESULT NOTIFICATIONS WILL AUTOMATICALLY BE SUBMITTED TO THE SCHOOL ATTENDANCE PERSONNEL FOR THE SCHOOL SELECTED.





EXCUSED

- ILLNESS OF THE STUDENT
- DEATH IN THE IMMEDIATE FAMILY
- INCLEMENT WEATHER WHICH WOULD BE DANGEROUS TO THE LIFE AND HEALTH OF THE STUDENT
- LEGAL QUARANTINE (INCLUDING COVID)
- LEGAL REQUIREMENTS FOR STUDENTS

- EMERGENCY CONDITIONS OR EXTENUATING CIRCUMSTANCES AS DETERMINED BY THE SUPERINTENDENT/PRINCIPAL/DESIGNEE
- RELIGIOUS HOLIDAYS, UPON RECEIVING PRIOR APPROVAL FROM THE STUDENT'S PRINCIPAL (THE SUPERINTENDENT'S DESIGNEE)
- EVENTS DIRECTLY RELATED TO MILITARY EVENTS OR ACTIVITIES.





UNEXCUSED

- ANY ABSENCE THAT DOES NOT FALL UNDER THE CATEGORY OF EXCUSED ABSENCE IS RECORDED AS AN UNEXCUSED ABSENCE.
- ALL ABSENCES WILL BE UNEXCUSED IF THE STUDENT AND PARENT FAIL TO PROVIDE THE STATEMENT WITH REQUIRED INFORMATION TO THE SCHOOL WITHIN THREE DAYS OF THE STUDENT'S RETURN TO SCHOOL (ALABAMA STATE POLICY).

EXAMPLES OF UA: VACATION, NO EXCUSE TURNED IN, TOO MANY PARENT NOTES (LIMIT 10 DAYS)



When to Stay Home from School

RASH

FEVER

A temperature of 100° or higher

COUGHING THAT WON'T STOP

Or other problems with breathing

DIARRHEA OR VOMITING

Within the past

24 hours

Body rash with itching and/or fever

HEAD LICE

Itchy head, active head lice

EYE INFECTION

Eye is red and oozing a yellow or green discharge













When to Return to School

hours without the use of fever reducing medication such as ibuprofen or acetaminophen Cough is mild and infrequent and evaluated by doctor if needed Free from diarrhea and/or vomiting for at least 24 hours and evaluated by doctor if needed Free from rash, itching or fever and evaluated by doctor if needed After first head like treatment 24 hours after starting antibiotic eye drops or ointment





OPTION 1:

YOUR STUDENT'S ATTENDANCE
IMPROVES, ALL FUTURE ABSENCES
ARE EXCUSED, AND YOU STAY IN THE
CLEAR.



OPTION 2:

ATTENDANCE DOES NOT IMPROVE, YOUR STUDENT REACHES 7 OR MORE UNEXCUSED ABSENCES, AND THE ATTENDANCE OFFICER VISITS THE JUVENILE PROBATION OFFICE TO FILE A PETITION AGAINST TRUANT STUDENTS AND/OR CHARGES AGAINST PARENTS/GUARDIANS/STUDENT.
